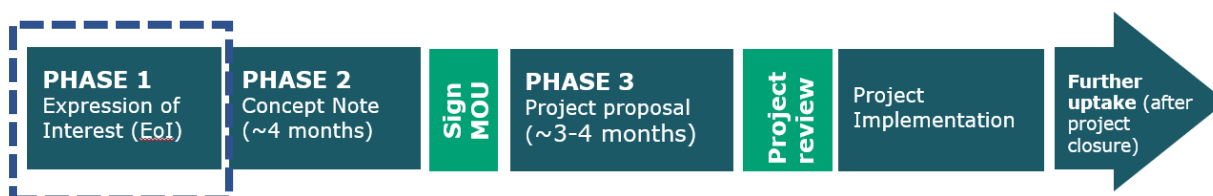


1. Introduction

The Expression of Interest (EoI) is the first phase of the ICARS application process (see Figure 1 below). As such, the EoI represents the first introduction to the country's AMR National Action Plan (NAP) and the priority AMR-sensitive and AMR-specific challenges/problems the country has identified. The EoI also provides the opportunity to highlight interventions that would potentially address these challenges and problems and how they would align with the NAP as well as other existing or planned AMR interventions in the country. The EoI must also include a reflection on how the respective Ministries will integrate learnings from any ICARS-supported intervention and implementation research project. Finally, the stakeholders that should be involved nationally and sub-nationally to bring such a project to fruition should also be highlighted.

The Responsible Ministry should coordinate the development and submission of the EoI.

2. Developing the EoI

The Responsible Ministry is requested to use the EoI template provided on the ICARS website. The EoI should not exceed 5 A4 pages.

3. Assessment Criteria

The EoI will be assessed by ICARS based on the following criteria (Table 2.):



TABLE 2. ASSESSMENT CRITERIA

Assessment Criteria
<ul style="list-style-type: none">• Are the AMR challenges/problems and the evidence to support them well articulated and described?
<ul style="list-style-type: none">• Are the interventions suggested to tackle priority AMR challenges/problems well described?
<ul style="list-style-type: none">• Are the respective Ministries clear in their commitment to addressing the AMR challenge/problem as well as using the results from any ICARS supported activities for scale up?
<ul style="list-style-type: none">• Are the stakeholders as proposed representing a good balance of top down (governmental) and bottom-up (researchers, implementers etc.) which would facilitate the success of implementation and scale up?

4. Submitting the EoI

The Responsible Ministry is requested to submit the EoI through the ICARS Application Submission System Portal. The point of contact for the Ministry will be required to create a profile on the Application Submission System, which will then become the primary means through which the various components of the project application will be submitted and evaluated.
